I agree to allow **Mutts n Pups Doggy Daycare**, _____ to use their best judgment in handling these situations, and I understand that **Mutts n Pups Doggy Daycare** and its staff assume no responsibility for the actions and decisions of the veterinary staff, the health, or death of my pet(s).

I will assume full responsibility for the payment and/or reimbursement for any and all veterinary services rendered, including but not limited to diagnosis, treatment, grooming, medical supplies, and boarding. Such payments will be made within 14 days of the initial incident. I also agree to be responsible for all additional fees assessed by for emergency transportation, care, or supervision of your pet(s) at \$25 per hour, and will pay such fees within 14 days of each incident.

I further authorize **Mutts n Pups Doggy Daycare** and my primary veterinarian(s) to share all of the medical records of all my animals with veterinary clinics in an emergency in the interest of providing the best care for my ill or injured animal(s).

This agreement is valid from the date below and grants permission for future veterinary care without the need for additional authorization each time **Mutts n Pups Doggy Daycare** cares for one or more of my pet(s). I understand that this agreement applies to each of the pet(s) within **Mutts n Pups Doggy Daycare** care. In signing this contract, I agree that I have the sole authority to make health, medical, and financial decisions regarding the animal(s) that will be scheduled to receive **Mutts n Pups Doggy Daycare** services.
